INSTRUMENT RENTAL POLICY

Effective August 2014

MONTHLY CHARGES Monthly rental charges are stated on the Rental Contract for the Instrument Outfit.

TERMS OF THE RENTAL CONTRACT The rental instrument "Outfit" consists of: one stringed-instrument (violin, viola or cello); one bow; and one case (hard case for violin/viola, soft case for cello). The Rental Contract and Policy shall together be known as the "Contract", and consists of one or more consecutive 3-month rental periods.

Renter is responsible for on-time payments for the life of the Contract. After the initial Contract payment, all future payments must be made by automatic payment using an approved valid credit card (MasterCard, Visa, or American Express). Renter will provide Hans Weisshaar with: a valid Driver's License; and two (2) approved, valid credit cards in his/her own name. Debit cards are not accepted. Renter agrees to notify Hans Weisshaar of changes to Rental Contract details including: Renter's address and telephone numbers, email address, credit card number, expiration date, billing address.

INSTRUMENT INSURANCE Hans Weisshaar does not provide insurance for the rental items and strongly recommends that Renter insure the Outfit. Upon request, Hans Weisshaar can provide a list of independent musical instrument insurance companies which offer comprehensive, cost-effective plans.

RENTAL CONTRACT DURATION Rental charges will be automatically charged to Rental Accounts at the beginning of every consecutive 3-month rental period. Renter agrees to provide a valid credit card to be charged automatically. No renewal statements or reminders will be sent by Hans Weisshaar. The Rental Contract will end when Renter has 1) settled all outstanding account balances in full AND 2) has returned the Outfit to Hans Weisshaar in its original condition.

RETURN OF RENTAL OUTFIT The Renter is responsible for the return of the Outfit to Hans Weisshaar at 627 N. Larchmont Blvd., Los Angeles, CA 90004. Hans Weisshaar does not provide pick-up and delivery of rental Outfits. All personal property such as photos, stickers, decals, tags, decorations, etc. on cases and instruments must be removed before Outfit is returned.

WARRANTY Our warranty covers string breakage within the first week of the entire Contract, and covers all original defects in workmanship or material (as determined by Hans Weisshaar) for the duration of the Contract.

MAINTENANCE, DAMAGE, NORMAL WEAR AND TEAR Renter is responsible for good care and regular maintenance of instrument, bow, and case during the Rental Contract. All maintenance on any part of Outfit shall be performed only by Hans Weisshaar. Under no circumstances shall Renter clean or polish the stringed instrument or bow with any liquid or solvent, or have cleaning, polishing, and repairs done by another party.

Upon commencement of Contract, the Condition of the instrument, bow, and case will be adjusted to the highest possible standard. Renter agrees to return the Outfit in the original condition at the end of the Rental Contract. If damage to the instrument or bow exceeds normal wear and tear, Hans Weisshaar reserves the right to charge for necessary repairs during the course of the Rental Contract or at the end of the Rental Contract.

RENT-TO-OWN Rent-to-Own is a purchase plan offered to the Renter whose account remains in good standing during the life of the Contract. All outstanding balances must be paid in full before a Rent-to-Own credit can be applied to purchase of a string instrument. The Rental Contract must be continuous and unbroken and accumulated rent cannot be combined with separate rental Contracts or transferred to another Renter.

- RENTAL CONTRACT REQUIREMENTS
1. Complete, sign, and date Hans Weisshaar Rental Contract
2. Sign and initial Hans Weisshaar Instrument Rental Policy
3. Renter's home address, telephone numbers, email address
4. Renter's current, valid Driver's License
5. Two valid credit cards (Visa, MasterCard, or AmEx) No debit cards.
6. Provide Reference 1: Music teacher's name (Instrument) with tel. no.
7. Provide Reference 2: name with telephone number
8. Name of private music teacher and school student attends

I have read and I agree to the above terms and requirements of the Hans Weisshaar Instrument Rental Contract and Policy. I agree that my valid credit card will be charged automatically at the beginning of each 3-month Rental Period. I agree to maintain and care for my Instrument Rental Outfit. I agree to inform Hans Weisshaar of any changes to my Rental Account details. I agree to pay for loss or damage to the Outfit.
